ELIMINATION OF THE DESIGNATED DISTRICT TRUSTEE SEAT

Upon recommendation of the Bylaws and Policies Committee, it was moved and adopted:

That the Kiwanis Children's Fund Board deletes Policy C.6 – Designated District Seat, as shown below. This change is effective October 1, 2021, and does not affect any existing trustees on the board previously appointed to this position.

Policy C. Board of Trustees

6. Designated District Seat

One of the three annual Trustee terms in each nominating cycle shall be designated as the Kiwanis Children's Fund district seat. The district filling this seat shall be chosen according to the following criteria, subject to relevant bylaw provisions regarding candidate requirements: (2/2018)

- Three points for highest per member average giving over a three-year period to the Unrestricted Fund of the Kiwanis Children's Fund.
- Three points for highest dollar amount average giving over a three-year period to the Unrestricted Fund of the Kiwanis Children's Fund.
- Two points for including the Kiwanis International Foundation District Chair in regular district board meetings and events to provide updates on the Kiwanis Children's Fund.
- Two points for having completed payment of its commitment or fair share to The Eliminate Project or any subsequent global campaign for children. (2/2018)

The qualifying district that earns the highest total points will be invited to submit three names to the Joint Committee for consideration.
