POLICY AND PROCEDURE REVISIONS

Upon recommendation of the Bylaws and Policies Committee, it was moved and adopted:

That the Kiwanis Children's Fund Board approves the revisions to policies and procedures, as shown in Exhibit A.

BYLAW AMENDMENT

Upon recommendation of the Bylaws and Policies Committee, it was moved and adopted:

That the Kiwanis Children's Fund Board approves the bylaw amendment shown below.

ARTICLE IV – COMMITTEES

Section 1. Standing Committees. The Foundation shall have the standing committees as defined in this article.

g. The Joint Committee of Kiwanis International and the Kiwanis International Foundation shall serve as a means of maintaining mutual understanding and cooperation between the Boards of Kiwanis International and the Kiwanis International Foundation. The committee shall consist of the Kiwanis International President, Immediate Past President, President-Elect, and Vice-President and the Kiwanis International Foundation President, Immediate Past President, President-Elect, and Treasurer. Except when conducting the annual appraisal of the Executive Director or when nominating candidates for the Foundation Board, The Kiwanis International President shall be Chairman, with the same voting privileges as other members.

The Joint Committee shall annually perform the appraisal of the Kiwanis International/Kiwanis International Foundation Executive Director which shall be conducted in accordance with Kiwanis International Procedure. For this role, the Immediate Past President of Kiwanis International shall act as Chairman.

The Joint Committee also shall recommend to the Foundation Board candidates for the offices of Foundation Trustee, Treasurer, President-elect, and President for the following administrative year. In the event that either the incumbent Treasurer or President-elect cannot succeed to the offices of President-elect and President respectively, then the Joint Committee shall also recommend to the Foundation Board candidates for such offices. For this role, the Foundation President shall act as chairman.

The Joint Committee may consider other matters of mutual interest to both organizations and is authorized to make recommendations to either or both boards.

The Joint Committee shall meet at the call of the Kiwanis International President, but in no event less than twice each administrative year.

APPROVAL OF US\$12,344 TO SUPPORT TWO GRANTS FOR PEDIATRIC TRAUMA

Upon recommendation of the Grants Committee, it was moved and adopted:

That the Kiwanis Children's Fund Board approves a total of US\$12,344 for pediatric trauma support, as follows:

- US\$8,000 to the Kiwanis Club of Alcoa, Tennessee, USA
- US\$4,344 to the Kiwanis Club of Chattanooga, Tennessee, USA

Treasurer Amy L. Zimmerman wishes to note for the record that the Kiwanis Children's Fund Board are aware of the current balance of the restricted funds and the amount budgeted to be granted for that year.
