KIWANIS ALCOHOL POLICY AND PROCEDURE

Upon recommendation of the Executive Committee, it was moved and adopted:

That the Kiwanis International Board revises Policy B.6 – Alcohol Guidelines, as shown below.

Policy B. International Administration

6. Alcohol Guidelines

Alcohol may be served or consumed at Kiwanis events in a legal and responsible manner, provided such serving or consumption is done in accordance with the customs and applicable laws where the club or other Kiwanis entity is located, and an adequate risk management program (to include liability insurance and adherence to legal requirements) is in place. (10/83) (1/20)

The use of membership dues or fees shall not be used for the purchase of alcoholic beverages for or by the Kiwanis International Board or Staff. (4/18)

The purchase of alcoholic beverages for any event produced or sponsored by Kiwanis International or its other entities shall be funded by non-dues revenues including but not limited to registration fees, separate ticket sales, and/or third party sponsorship or underwriting.

Because the presence of alcohol at a function greatly increases the risk of personal injury, Kiwanis clubs and other Kiwanis entities must be conscious of liability exposure whenever alcohol is offered. All Kiwanis entities should adhere to the alcohol guidelines established by Kiwanis International when providing alcohol at an event; see Procedure 173 – Alcohol Guidelines for Kiwanis Clubs and Other Kiwanis Entities. (10/83) (1/13)

KIWANIS ASIA-PACIFIC DISTRICTS MATCHING GRANT REQUESTS

Upon recommendation of the Board Committee on Membership, it was moved and adopted:

That the Kiwanis International Board approves the matching grant request from the Nepal District in the amount of US\$7,850 for club leadership education efforts.

Further, that the Kiwanis International Board approves the matching grant request from the Philippine Luzon District in the amount of US\$7,850 for club leadership education efforts.

TAIWAN DISTRICT REQUEST TO DETACH CAMBODIA

Upon recommendation of the Board Committee on Membership, it was moved and adopted:

That the Kiwanis International Board approves the formal detachment of the Kiwanis Club of Metro Phnom Penh (KCMPP) in Cambodia from the Taiwan District.

CLUB ATTACHMENTS TO DISTRICTS

Upon recommendation of the Board Committee on Membership, it was moved and adopted:

That the Kiwanis International Board approves the formal attachment of the Kiwanis Club of St Pierre de la Réunion to the France-Monaco District and the Kiwanis Club of Chisinau, Moldova, to the Romania Provisional District.

MANDATORY REQUIREMENT FOR U.S. CLUBS TO ESTABLISH AN EIN AND FILE IRS FORM 8976

Upon recommendation of the Board Committee on Membership, it was moved and adopted:

That the Kiwanis International Board requires all newly-chartered U.S. Kiwanis clubs to submit their tax identification number (EIN) and a copy of IRS Form 8976 - Notice of Intent to Operate as a 501(c)(4) to Kiwanis International at the same time as they submit their organizational paperwork (roster, bylaws, and charter fee payment). This requirement is effective October 1, 2020. This requirement will save clubs from having to pay fines to the government for not completing these steps.

ROMANIA PROVISIONAL DISTRICT REQUEST FOR DUES RELIEF 2019-20

Upon recommendation of the Board Committee on Membership, it was moved and adopted:

That the Kiwanis International Board provides a grant for clubs in the Romania Provisional District for the 2019-20 administrative year equal to the difference between Tier A dues (US\$52) and Tier C dues (US\$23), for an estimated total of US\$18,073.

YOUTH PROTECTION

That the Kiwanis International Board requires that, effective September 1, 2020, any advisor to any Service Leadership Program (SLP) that does not have a valid clear criminal history background check on file with Kiwanis International will be removed from their position as advisor.

Further, the Kiwanis International Board directs staff to send written notice to individual schools or other facilities advising of the removal of authorization of Kiwanis advisor for all individuals who previously served as advisor but are not in compliance with Kiwanis International's criminal history background check requirements.
