#### DEFINITION OF AN INTERNET CLUB & CLUB NAMING PROCEDURE

Upon recommendation of the Board Committee on Membership, it was moved and adopted: That the Kiwanis International Board approves the following changes to Procedure 301.4 – Club Name. This change shall be effective October 1, 2021.

# **301.4** - Club Name (4/15)

- **A. Official Name:** To conform with the Bylaws, the official name of a Kiwanis club shall commence with the three words "Kiwanis Club of \_\_\_\_\_\_\_." The official name shall then be used for the club's articles of incorporation. The name of the club shall be lettered on the club banner as it appears in the club's bylaws.

  (6/91)
- **B.** Geographic Location: The club name shall include the city, geographical location, or corporate area, and may be followed by the unabbreviated name of the country, state, province, or territory. (Examples: Kiwanis Club of Calgary, Alberta, and Kiwanis Club of Santa Rosa, Philippines.) (6/91) (4/15)
- C. Honoring an Individual: A Kiwanis club shall not be named to honor an individual. (Existing clubs as of April 2015 are grandfathered as exempt from this rule.) (1980) (4/15)
- **D. Prohibitions:** A club shall not use in its name: a specific gender designation, such as the words "man/woman," "men/women," or "male/female," nor shall it use any designation which would impugn the good name of Kiwanis. A club's name shall not include: (10/90) (4/15)
  - The name of an individual, living or deceased. (However, existing clubs as of April 2015 are grandfathered as exempt from this rule.)
  - Any gendered language (including pronouns) or demographic descriptors.
  - Any corporate or brand affiliation.
  - Any wording which is incongruent with the Kiwanis Objects or which could reasonably impugn the good name of Kiwanis.

# LIFE MEMBERSHIP IN KIWANIS INTERNATIONAL FOR FORMER KCI AND CKI PRESIDENTS

Upon recommendation of the Board Committee on Membership, it was moved and adopted:

That the Kiwanis International Board provides complimentary life membership to former presidents of Circle K International and Key Club International as follows. This shall be effective October 1, 2021, beginning with the leaders of the 2020-21 administrative year.

# <u>Procedure 198 – Complimentary Life Membership for Past Presidents of Key Club</u> International and Circle K International

Kiwanis International provides complimentary life membership to former presidents of Key Club International and Circle K International by waiving Kiwanis International dues when they voluntary join a Kiwanis club of their choice and for such time that they continue as Kiwanis club members. All other applicable dues and fees shall remain payable, including club dues, district dues, the magazine subscription, and the insurance premium.

#### ADMINISTRATIVE ACTION REPORT

# ENROLLMENT FEE WAIVER FOR MEMBERS OF NEW CLUBS – JULY 1-SEPTEMBER 30, 2021

In an effort to incentivize membership growth and club opening at the end of the year and to ease the transition to a new prorated dues system at the start of the 2021-22 year, the Kiwanis International Board approved a waiver of the US\$50 enrollment fee for new members of clubs that are opened between July 1 and September 30, 2021.

Upon motion duly made by Vice President Bert West and seconded, the following recommendation was adopted:

That the Kiwanis International Board waives the Kiwanis International enrollment fee as defined in Procedure 342.2 – Enrollment Fee, for members of new clubs that are formed between July 1, 2021, and September 30, 2021.
