January 19, 2023

KIWANIS INTERNATIONAL BYLAWS MODERNIZATION REVISION

That the Kiwanis International Board approves adjustments to the Kiwanis International Bylaws Modernization Revision which incorporate the bylaw amendments previously adopted by the House of Delegates at the 2022 Kiwanis International convention as well as one additional clarification identified by the Governance Committee.

POLICY AND PROCEDURE UPDATES

Upon recommendation of the Executive Committee, it was moved and adopted:

That the Kiwanis International Board approves revisions to policies and procedures as shown in Exhibit A.

CO-SPONSORING OF AMENDMENT/RESOLUTION PROPOSALS

That the Kiwanis International Board approves new Procedure 123.4 – [Resolutions Committee] Submitting Body, as shown below, clarifying that each resolution or amendment may only be proposed by one entity.

123 – Resolutions Committee

123.4 - Submitting Body

A club or district that proposes a resolution or bylaw amendment according to the provisions in the bylaws shall be listed as the official proposer of the resolution or amendment. In the case of more than one club and/or district proposing the same resolution or amendment, the official proposer shall the club or district that submits the proposal to Kiwanis International first. There shall not be more than one official proposer for each resolution or amendment.

Upon recommendation of the Executive Committee, it was moved and adopted:

PHILIPPINES SOUTH DISTRICT UPDATE

Upon recommendation of the Executive Committee, it was moved and adopted:

That the Kiwanis International Board directs the following actions by the Philippine South District:

- Confirm the 2023 district convention will be held May 11-13 in Iloilo City.
- Present amended district bylaws for adoption by clubs that will include provisions for governor rotation between the Visayas and Mindanao regions of the district, and a requirement that convention delegates may be certified only for clubs that are in good standing, which includes payment of dues, at least thirty days before the district convention. The final draft of the amended district bylaws should be approved by the Kiwanis International Board at its April meeting.
- Confirm that the sole candidate for 2023-24 Governor shall be the person who most recently held the office of Governor-elect (Gigi Chan Chu, Visayas region, who is currently serving as district chair)
- Confirm plans at the coming convention to elect a new Governor-elect (2023-24) from the Mindanao region.

That the Kiwanis International Board accepts the 2021-22 consolidated audit report for Kiwanis International, Kiwanis Europe, Circle K International, Kiwanis Youth Programs, and Kiwanis Children's Fund, and the related Audit Committee Letter.

APPROVAL OF 2022-23 AUDITORS

Upon recommendation of the Audit and Finance Committee, it was moved:

That the Kiwanis International Board selects Forvis, LLP as auditors for Kiwanis International, Kiwanis Europe, Circle K International, Kiwanis Youth Programs, and Kiwanis Children's Fund for the 2022-23 administrative year.

MODIFICATION TO DISTRICT IN GOOD STANDING POLICY

Upon recommendation of the Board Committee on Audit and Finance it was moved and adopted:

That the Kiwanis International Board temporarily adjusts the requirement of Procedure 204.1.d – Minimum Requirements for Good Standing so that, for current fiscal year 2022-23 and previous fiscal years, districts, district foundations, and Key Club and Circle K districts are not required to submit audited financial reports or third-party review reports, but rather shall provide financial reports certified by the district, district foundation, or Key Club or Circle K district that the reports are accurate and that the district's governmental reporting is in compliance with laws and regulations of local jurisdiction.

That the Kiwanis International Board approves Diversity Equity and Inclusion funding in the amount of US\$1,500 for 2022-23 for the purpose of a speaker at the Kiwanis International convention.

OTHER BUSINESS

REFERRAL TO THE BOARD COMMITTEE ON AUDIT AND FINANCE:

That the Kiwanis International board refers a review of governance provisions regarding required audits be referred to the Audit and Finance Committee, particularly Policy E, K.I. Bylaws Article IX, Section 21, and K.I. Bylaws Article X, Section 3

DUES ADJUSTMENT AMENDMENT

That the Kiwanis International Board rescinds the following motion adopted at the October 8, 2022, Board meeting to make changes to the publications fee:

It was further resolved that elimination of the official publications subscription fee be proposed as a separate amendment from the dues adjustment, with the separate amendment to incorporate a communications fee of US\$6 per member for all clubs in Tier A nations. The Board directs staff to provide wording for such an amendment for review by the Board at its next meeting in January.

Therefore, the following final proposed amendment to the Kiwanis International Bylaws regarding a Kiwanis International dues adjustment to be submitted to the House of Delegates at the 2023 convention will be as follows, with no changes to Article XXI – Official Publications:

ARTICLE XXII. REVENUE

Section 1. Subject to Sections 2 and 3 of this Article, each club shall pay to Kiwanis International for each member, with the exception of those holding life member status, the sum of fifty two dollars (US \$52) eighty-two dollars (US \$82) per annum. Such sum shall be based on each club's annual membership report as of September 30 of each year and shall be due annually on October 1 and payable by November 30. (6/2015) (*See also Interpretations.*)

Section 2. The Board of Trustees shall adjust the dues from the clubs in any country where the Gross National Income per capita is less than ten thousand dollars (US \$10,000) as reported by the World Bank. The schedule for payment shall be as follows: (6/2015)

- Tier A: Countries with per capita income US \$10,000 or more pay US\$52 shall pay the amount stated in Section 1. (6/2015)
- Tier B: Countries with per capita income US \$5,000 to US \$9,999 shall pay US\$34 US\$54.
- Tier C: Countries with per capita income US \$4,999 or less shall pay US\$23 US\$36.
