KIWANIS CHILDREN'S FUND PETITION TO CHANGE K.I. POLICY ON COMPOSITION OF C §5 (G) JOINT COMMITTEE

Motion made by Executive Committee:

That the Kiwanis International Board accepts the change to the Kiwanis Children's Fund Bylaws respectfully requested by the Kiwanis Children's Fund Board to change the composition of the Kiwanis International-Kiwanis Children's Fund Joint Committee, reflected in Kiwanis International Policy C §5(g) to more evenly reflect representation from both boards. The change would be as follows:

Joint Board Committee: As a means of maintaining mutual understanding and cooperation between the boards of trustees of Kiwanis International and the Kiwanis International Foundation, a Joint Committee shall be established and maintained, consisting of the Kiwanis International President, Immediate Past President, President- Elect, and Vice President and one member of the Kiwanis International Foundation Board selected by the Kiwanis International President the Kiwanis International Foundation President, Immediate Past President, President-Elect and Vice President. The Kiwanis International President shall be Chairperson, with the same voting privileges as other members. (10/11) (10/23, effective 11/23)

KIWANIS CHILDREN'S FUND BYLAW AMENDMENTS TO ARTICLE 2 §2 COMPOSITION OF BOARD

Motion made by the Executive Committee:

That the Kiwanis International Board accepts the amendment to the Kiwanis Children's Fund Bylaws Article 2 §2, as follows, changing the Trustee terms from two (2) year terms to three (3) year terms effective with the fiscal year 2026-27 appointment cycle.

ARTICLE II – BOARD OF TRUSTEES

Section 2. Composition of Board. The Foundation Board shall be composed of: (7/2014) a. With the exception of the two Kiwanis International Representative Trustees:

2. Each Trustee shall serve a two (2) (3) three-year term, beginning on October 1 following appointment and ending on September 30 two (2) three (3) years thereafter. (3/2023)

KIWANIS CHILDREN'S FUND BYLAW AMENDMENTS TO ARTICLE 2 §7 BOARD MEETINGS

Motion made be the Executive Committee:

That the Kiwanis Children's Fund Board amends the Kiwanis Children's Fund Bylaws Article 2 §7 Board Meetings as follows:

"Section 7. Board Meetings. The Foundation Board shall hold at least two meetings each administrative year. a. The Annual meeting, which shall be held in conjunction with the annual Convention of Kiwanis International, Inc., in the same city as that Convention; and. b. One other meeting, which shall be held at a time and a place determined by the Board. The Board may hold additional meetings called by the President or at the request of at least four (4) members of the Board. The Board may hold any annual, regular, or special meetings inside or outside Kiwanis International Headquarters."

<u>UPDATE TO ARTICLE 17. CONVENTION PROCEDURES SECTION 3 (UPDATE TEXT</u> FOR PROPOSING RESOLUTIONS)

Motion made by the Executive Committee:

That the Kiwanis International Board proposed the following change to Article 17 Section 3 to the 2025 House of Delegates:

ARTICLE 17. CONVENTION PROCEDURE Section 3.

a. Proposed resolutions shall be submitted <u>at any time but not later than by October 31</u> prior to the next scheduled Kiwanis International convention by a <u>district</u> board or <u>district</u> house of delegates <u>of a district in good standing</u>, or by a club in good standing, by a majority vote of the members. Resolutions may also be proposed by the Kiwanis International Board. (6/2023)

ALLOWING REGIONAL BOARDS TO PROPOSE RESOLUTIONS AND AMENDMENTS

Motion made by the Executive Committee:

That the Kiwanis International Board propose an amendment to the Kiwanis International Bylaws as follows to allow regional boards to propose resolutions and amendments:

ARTICLE 17. CONVENTION PROCEDURE Section 3.

a. Proposed resolutions shall be submitted by at any time but not later than October 31 prior to the next scheduled Kiwanis International convention by a district board or district house of delegates of a district in good standing, by the board or house of delegates of a region, or by a club in good standing, by a majority vote of the members. Resolutions may also be proposed by the Kiwanis International Board. (6/2023)

ARTICLE 27. AMENDMENTS TO BYLAWS AND RESCISSION OF INTERPRETATIONS

Section 4. All proposals stated in Sections 1, 2, and 3 may be submitted by: (6/2023)

- a. The Kiwanis International Board; (6/2023)
- b. The board or house of delegates of a district in good standing; or (6/2023)
- c. The board or house of delegates of a region; or
- d. A club in good standing, by a majority vote of the members. (6/2023)

- a. New Asia-Pacific Bylaws being ratified adopted by Asia-Pacific and approved by Kiwanis International.
- b. Asia-Pacific becoming a registered legal entity with its own bank accounts.
- c. Creation of a work plan and detailed budget.

CLUB OPENING FUNDING

That the Kiwanis International Board approves an additional budget funding for US\$125,000 for club opening events in Jacksonville, Florida, Texas-Oklahoma District and New Jersey District during the 2024-25 administrative year.

REVIEW BUDGET REQUEST FOR ASIA-PACIFIC EDUCATION CONFERENCE

Motion made by Trustee Trinidad P. Gonzales, and seconded:

That the Kiwanis International Board approves the restoration of the budget of US\$58,100 for the 2024-25 Asia-Pacific Education Conference in Kaohsiung, Taiwan.

UTILIZING KIWANIS AMPLIFY TO STRENGTHEN THE LEADERSHIP PIPELINE

Motion made by Trustee Steven R. Ingram, and seconded:

That the Kiwanis International Board chooses the option below to enhance the Kiwanis Amplify program and strengthen Kiwanis International Leadership Pipeline.

1. Offer "buy one, get one" participation for clubs built within the last year: This option presents a straightforward marketing opportunity, as staff can directly engage with each club to offer the incentive. Additionally, it can be extended to newly established clubs during the period of January to March 2025. A key aspect of this option is that it requires clubs to demonstrate commitment by funding one registration. Staff have observed that this investment significantly encourages program completion.

PROPOSED CONDUCT UNBECOMING POLICY CHANGE

Motion made by Trustee Steven R. Ingram, and seconded:

That the Kiwanis International Board amends Kiwanis International Policy B §a as shown below:

- 11. Definition of 'Conduct Unbecoming'
 - a. Conduct Unbecoming a Member of the Kiwanis Family (4/13)

"Conduct unbecoming a member of the Kiwanis family" is defined as any conduct that: (4/12)

- Constitutes harassment of another individual based on race, color, creed, national origin, age, or sex, including sexual orientation and gender identity. (10/21)
- Constitutes a criminal act that is clearly incompatible with the best interests of the public or of members of the Kiwanis family; or (4/12) (10/21)
- Constitutes repeated offensive or obnoxious behavior at Kiwanis events and activities <u>as</u> determined by at least 2 thirds of the board of directors of a club or district as it relates to conduct unbecoming charges at the club or district level. (10/21)

Note: For conduct unbecoming purposes, the Kiwanis family is defined in the Kiwanis International Bylaws as members of Kiwanis clubs, Aktion Clubs, Circle K clubs, and Key Clubs. (4/12)

Motion adopted.

BOARD POSITION ON THE PROPOSED AMENDMENT FOR CONVENTION- CAPITAL DISTRICT

Motion made by Vice President Hope Marks, and seconded:

That the Kiwanis International Board does not support the proposed amendment from the Capital District, U.S., to require remote voting at Kiwanis International Conventions.

KIWANIS CHILDREN'S FUND- KIWANIS YOUTH PROGRAMS STRUCTURAL REALIGNMENT

Motion made by President-elect Michael Mulhaul, and seconded:

That the Kiwanis International Board requests staff to <u>investigate and report on the possible</u> structural realignment of the two 501(c)(3) subsidiaries, Kiwanis International Foundation d/b/a Kiwanis Children's Fund and Kiwanis Youth Programs, Inc., for the Board's review and consideration at the April 2025 Board meeting.
