PENNSYLVANIA DISTRICT CHAIR APPOINTMENT

That the Kiwanis Children's Fund Board appoints Jen Vare from the Pennsylvania District as Kiwanis Children's Fund District Chair for the Pennsylvania District for a three-year term or the duration of the campaign, effective immediately.

REPORT OF THE GRANTS COMMITTEE

The report of the 2024-25 Grants Committee, Lenora J. Hanna, Chair, was presented.

Motion made by President-elect Lenora J. Hanna:

CHANGES TO KICKSTARTER PROGRAM

That the Kiwanis Children's Fund Board approves changes to the Kickstarter Grant Program and subsequent necessary policy changes to Policy H(4). New Kiwanis clubs that charter with 30 or more members are eligible for a grant of up to US\$1,000. This change will be retroactive as of October 1, 2024.

4. KICKSTARTER (11/24)

- a. New Kiwanis clubs that charter with 40 <u>30</u> or more active members will be invited to apply for a Kickstarter grant of up to US\$1,000 for Tier 1 and up to US\$500 for Tier 2 clubs. Clubs will be eligible to apply on their organization date and up to 120 days following their organization date.
- b. If the <u>a</u> club maintains or grows its membership of <u>to</u> 40 or more active members one year after its organization date, it is eligible to apply for a second grant of up to US\$1,000 for Tier 1 and up to US\$500 for Tier 2 clubs up to 120 days following the organization date's one-year anniversary.
- c. Grant recipients must comply with the terms and conditions of the grant as set by the Foundation.

PEDIATRIC MEDICINE SUPPORT GRANT

That the Kiwanis Children's Fund Board approves US\$15,640 for Pediatric Medicine Support Grants.

- US\$11,000 for the Kiwanis Club of Harrison (Missouri-Arkansas District): A Kiwanis Children's Fund Grant would be used to support the purchase of therapy equipment for the sensory gym.
- US\$4,640 for the Kiwanis Club of Anthem Ranch (Rocky Mountain District): A Kiwanis Children's Fund Grant would be used to support the purchase of soothing sensory equipment and safety modifications for the rooms.

APPROVAL OF MATERNAL AND NEONATAL TETANUS (MNT) GRANT REQUEST
